# **Call for Paper**

We invite contributions for oral presentations from a variety of perspectives and approaches asking questions with reference to Gender and Marginalisation. We encourage you to submit abstracts from across multiple disciplines dealing with aspects that impact (re)production and experience of non-belonging. Besides race, class, and gender those factors can be age, disability, sexual orientation, or social status.

We organise panel and workshop sessions. In panel sessions there will be 20 minutes for presentation and a short discussion afterwards. Workshops are 90-minute sessions with the opportunity to frame an issue (max. 20 minutes) and then have a focused discussion with an active interdisciplinary pass on knowledge.

Potential themes include, but are not limited to:

- theoretical approaches to gender & marginalisation
- (interdisciplinary) methods of studying gender & marginalisation
- gender & marginalisation in different fields, e.g. the criminal justice system, education system, activism, technology and artificial intelligence, security, health system, religion, socio-spatiality ...
- research ethics in the context of gender and processes of exclusion
- historicisations

Please send your proposal as an anonymous document with an abstract (max. 300 words) and, if you like, with a short personal introduction (max. 150 words) by the **20<sup>th</sup> February 2023** in English or German to:

### Prof. Dr. Anika Gomille

Her research interests include sociology of knowledge, discourse research, gender studies, sociological theory, and qualitative social research.

Dörte Negnal is a lecturer in Critical Criminology, Sociology and Social Work at the University of Siegen. Her interdisciplinary research agenda is focused on qualitative research methods, statehood, social problems, and social control. She joined the University of Siegen as a lecturer in criminology, after finishing her doctoral studies in Sociology of Social Problems at the University of Kassel with an ethnographic work on constructing social groups via danger.
